NOTIFICATION

The following notification is being circulated in accordance with Article 13

1.	Party to the Agreement notifying: <u>Republic of Albania</u>
2.	Agency responsible: Ministry of Environment. Name and address (including telephone and fax numbers and E-mail and Web site addresses, if available) of agency or authority designated to handle comments regarding the notification shall be indicated if different from above: National Enquiry Point.
3.	Products covered (HS or CCCN where applicable, otherwise national tariff heading. ICS numbers may be provided in addition, where applicable): Integrated chemicals.
4.	Title, number of pages and language(s) of the notified document: Draft law of Parliament "On integrated chemicals management" (33 pages, available in Albanian language).
5.	Description of content: This draft law of the Parliament determines the obligations to producers, importers and users of the integrated chemicals placed in the market and provides the appropriate documents in data security for them; it defines obligations to all suppliers to the labelling and packaging of chemicals; etc.
6.	Objective and rationale, including the nature of urgent problems where applicable: The aims of this draft law are to ensure the free movement of chemicals and other goods, as well as to increase the competition and innovation; to harmonize legislation in the Republic of Albania to the Global Harmonized System for classification and labelling of chemicals (GHS); etc.

Relevant documents: – Regulation (EC) No. 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), establishing a European Chemicals Agency, amending Directive 1999/45/EC and repealing Council Regulation (EEC) No 793/93 and Commission Regulation (EC) No. 1488/94 as well as Council Directive 76/769/EEC and Commission Directives 91/155/EEC, 93/67/EEC, 93/105/EC and 2000/21/EC. – Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No. 1907/2006
